On 22 October 2018, the Company entered into a sale and purchase agreement with the Vendor to acquire 100% equity interest of the Target Group at the consideration of HK\$76,000,000, which was satisfied by the issue and allotment of 425,568,000 Consideration Shares at the Issue Price of HK\$0.131 per Consideration Share by the Company to the Vendor and the remaining amount of HK\$20,250,592 by the issue of the Promissory Note by the Purchaser to the Vendor upon Completion. The Acquisition was completed on 22 January 2019. Details of the Acquisition were set out in the Company's announcement dated 22 October 2018, 30 November and 11 December 2018 and Company's circular dated 13 December 2018.
