Reference is made to the circular (the “AGM Circular”) of Food Idea Holdings Limited (the “Company”) and the notice (the “AGM Notice”) of the annual general meeting (the “AGM”) dated 10 April 2018. Capitalised terms used in this announcement shall have the same meanings as those defined in the AGM Circular unless otherwise defined herein.

As at the date of the AGM, the total number of issued shares in the Company was 2,127,854,643, which was the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM. No Shareholder was required to abstain from voting on any resolutions proposed at the AGM as required by the GEM Listing Rules, and no Shareholder has stated his or her intention in the AGM Circular to vote against or to abstain from voting the resolutions proposed at the AGM. No Shareholder was entitled to attend and abstain from voting in favour of any resolutions at the AGM as required by the Rule 17.47A of the GEM Listing Rules.

The Company’s Hong Kong share registrar and transfer office, Union Registrars Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.
