Pursuant to sections 9 and 10 of the Securities (Disclosure of Interests) Ordinance, Asia Orient Co. Ltd. and Yue Xiu Enterprises Ltd. have entered into an acquisition agreement whereby Asia Orient has agreed to purchase a company which will hold 10% issued shares (121,500,000 shares) of Asia Standard International Limited (stock code: 129) from Yue Xiu Enterprises Limited upon completion of the transaction. The acquisition was not completed as at 19 November 1991. The two parties have total concert party interests of 873,120,148 shares in Asia Standard International Limited.
