Chi Cheung Investment Company Ltd ("Chi Cheung")

As on 7th December 1993, Goodwill International (BVI) Limited, a subsidiary of Goodwill Internatinal (Holdings) Limited (the "Company"), acting as the Vendor, entered into 3 sale and purchase agreements with the following 3 parties as the Purchasers under their respective terms as follows:

- (a) with Kailly Limited, of Skelton Building, Main Street, P O Box 3136, Road Town, Tortola, British Virgin Islands, in relation to a sale and purchase of 18,500,000 shares of HK\$0.20 each in Chi Cheung Investment Company, Limited at a price of HK\$3.30 per share and which sale and purchase shall be completed by 15th January 1994;
- (b) with Baird Developments Limited, of P O Box 71 Craigmuir Chambers, Road Town, Tortola, British Virgin Islands, in relation to a sale and purchase of 5,600,000 shares of HK\$0.20 each in Chi Cheung at a price of HK\$3.30 per share and which sale and purchase shall be completed by 30th January 1994;
- (c) with Diamond Peak Resources Limited, of P O Box 71 Craigmuir Chambers, Road Town, Tortola, British Virgin Islands, in relation to a sale and purchase of 4,400,000 shares of HK\$0.20 each in Chi Cheung at a price of HK\$3.30 per share and which sale and purchase shall be completed by 30th January 1994;

making a total disposal of 28,500,000 shares in Chi Cheung. By the completion of the 3 sale and purchase, the Company shall hold 13,514,720 shares (7.4%) in Chi Cheung ceasing to be a substantial shareholder of Chi Cheung.
