- N1 Pursuant to a sale and purchase agreement dated 10 October 1994, each of Mr. Chui Fat Chuen, David ("Mr Chui") and Mrs Chui Lau Sau Chun, Lillian ("Mrs Chui") transferred 57,600,000 shares and 11,520,000 warrants of Rhine Holdings Limited (the "Company") to White Angel Holdings Limited ("WAH"). In consideration for such transfers, WAH issued a non-interest bearing deed of indebtedness representing the aggregate market value of 57,600,000 shares and 11,520,000 warrants to each of Mr. and Mrs Chui. WAH is the trustee of The Chui Unit Trust ("UT"), the beneficiaries of which are (1) Amex International Trust (Cayman) Ltd., in its capacity as trustee of The Chui Family Trust 1994, which owns approximately 99.9% of the total units in issue of the UT; and (2) Liheng Industries and Development Limited, the shares of which are equally and beneficially owned by Mr. and Mrs Chui. Liheng Industries and Development Limited owns approximately 0.1% of the total units in issue of the UT.
