- N1 On 29/12/94, 18,550,000 shares included in the interest in 81,050,000 shares held through a first fixed charge over such shares given by Daqing Qingda Economic and Trading (Holdings) Corporation ("Qingda") in favour of Century City Finance Limited ("CCF") as security for a loan facility granted by CCF to Qingda ("Share Charge") were released. Accordingly, the number of shares held under the Share Charge was reduced to 62,500,000 shares.
- On 30/12/94, 18,750,000 shares held under the Share Charge were released. Accordingly, the number of shares held under the Share Charge was reduced to 43,750,000 shares.
- N2 1,381,562,617 shares were held through companies controlled by Century City International Holdings Limited ("CCIHL"), of which interest in 81,050,000 shares was held through a first fixed charge over such shares given by Daqing Qingda Economic and Trading (Holdings) Corporation ("Qingda") in favour of a company controlled by CCIHL as security for a loan facility granted by such company to Qingda (the "Share Charge").
