- N1 Exercise of 33,642,346 units of warrants on 30/03/95.
- N2 Pursuant to a Placing Agreement entered into by Choi Sai Leung and The New China Hong Kong Corporate Finance Ltd., Mr. Choi was deemed to be interested in 156,102,000 shares in Seapower Int'l Holdings Ltd. and had undertaken not to dispose of these shares for a 6-month period starting from 30/09/94. Upon the expiry of the 6-month period on 30/03/95, Mr. Choi has ceased to have the deemed interests in such shares.
- N3 Exercise of 20,000,000 units of warrants on 23/03/95.
- N4 Pursuant to a deed of put option entered into between Yaohan International Co. Ltd. ("YICL") and Mr. Wilson Wong ("Mr. Wong") on 27 November 1992 and a put option entered into by YICL and Mr. Tam Wing Hong ("Mr. Tam") on 27 November, 1992, Mr. Wong has exercised his right of put option to sell to YICL. The YFPT shares in the number of 14,062,500 shares. Mr. Tam has also exercised his right of the put option to sell to YICL the YFPT shares in the number of 3,750,000 shares. Both transactions to be completed on 19 April, 1995. Total consideration for the exercise of the option is HK\$26,030,843.
