- N3 Acquisitions were made from 04/05/95 to 08/05/95 at prices ranging from HK\$0.54 to HK\$0.57/share.
- N4 3,167,000 shares in Lai Sun Development Company Limited which are owned by U Po Chu have been separately reported by her as director of the company. Accordingly, the present balance had been adjusted by deducting 3,167,000 shares from 2,438,169,701.
- N5 85,500,508 shares in Lai Sun Garment (International) Limited are comprised of shares from the following owners, that is to say, 77,476,350 shares from Lim Por Yen, 3,933,800 shares from U Po Chu and 4,090,358 shares from Lai Yuen Fong. U Po Chu and Lai Yuen Fong are the spouse of Lim Por Yen. 3,933,800 shares owned by U Po Chu should have been deducting from the total of 85,500,508 shares for reason that U Po Chu is a director of Lai Sun Garment (International) Limited. Having deducting this number of shares, the previous balance should have been stated as 81,566,708 shares representing 77,476,350 shares owned by Lim Por Yen and 4,090,358 shares owned by Lai Yuen Fong.
