- N1 Pursuant to a share mortgage dated 11 May 1995, Excellent Fortune Limited granted an equitable mortgage over 27,910,000 Shares in Best Wide Group Limited in favour of PCFL (Finance) Limited.
- N2 7,500,000 shares of Hutchison Whampoa Ltd (HWL) are taken as interested through Cheung Kong Holdings (CKH) by virtue of 75,000,000 call warrants 1995-1997 (the "Warrants") agreed to be acquired by a wholly-owned subsidiary of CKH on 11th May, 1995 at price of HK\$1.23 per Warrant. The Warrants were agreed to be issued by Peregrine Derivatives Limited at an issue price of HK\$1.23 per Warrant pursuant to a placing agreement entered into on 11th May 1995 between Peregrine Derivatives Limited, Peregrine Investments Holdings Limited and Peregrine Brokerage Limited. Every ten Warrants will give their holder the right initially to purchase one share in HWL at the exercise price of HK\$32.00 per share (subject to adjustment) or, at the option of Peregrine Derivatives Limited, to be paid an amount in cash.
