- N1 Silverlink (Hong Kong) Enterprises Limited ("Silverlink") is deemed to be interested in 100,000,000 shares in Styland Holdings Ltd pursuant to a Charge over Securities dated 14th August, 1995 executed by Cheung Chi Shing and K.Y. Limited as mortgagors in favour of Silverlink as lender. The deemed interest is held by Silverlink as security for a loan facility granted by Silverlink to K.Y. Limited pursuant to the terms of a loan agreement dated 2nd August, 1995 made between K.Y. Limited as borrower and Silverlink as lender.
- N2 The Exchange has received a Director's/Chief Executive's Notice from Mr. Makie Hui Po Yuen reporting a decrease of his interests in Yeebo (International Holdings) Ltd. ("Yeebo") (Stock code: 259) by 27,330,000 shares. The 27,330,000 shares constitute part of the 40 million shares pledged in favour of three individuals to secure certain loans granted by those individuals to Mr. So Kin Keung, Chairman of Kin Son Electronic (Holdings) Co. Ltd. (For details of the loans, please refer to the press announcement of 2 August 1995 by Yeebo.) Mr. Hui has reported that on Wednesday, 9 August 1995 he was given proof of the transfer of 27,330,000 shares and that the disposals were made between April 1995 and August 1995.
