N1 The Exchange has been notified by Fortune Leader Ltd that with effect from 24 August 1995, all the existing Old Shares of Hoi Sing have been consolidated on the basis of four Old Shares to one Consolidated Share. On 29 August 1995, in connection with a rights issue by Hoi Sing of 149,070,430 new Consolidated Shares, Hoi Sing issued a prospectus, provisional allotment letters and application forms for excess Rights Shares to its shareholders. Pursuant to an underwriting agreement dated 31 July 1995 between Fortune Leader and Hoi Sing, Fortune Leader is acting as the underwriter of the Rights Issue.
