- N1 On 18 January 1996, Joyful Capital Limited ("Joyful") entered into a conditional agreement (the "Agreement") with Sum Yuk Bui, Shum Wai Piu, Shun Kui Piu, Shum Chuen Piu, Kasugai Investments Limited, Solarun Limited and Ronjet Limited (together the "Vendors") for the acquisition by Joyful from the Vendors of an aggregate of 28,000,000 ordinary shares in the existing issued share capital of the Company together with all rights attaching thereto, including the entitlement to the one for ten bonus issue of the Company, announced on 19 December 1995. Completion of the acquisition contemplated by the Agreement took place on 22 March 1996.
