- N6 Pursuant to a Share Charge dated 19th December 1996 entered into between Wong Kam Fu and Chu Wai Fun as the chargors (the "Chargors") and China Strategic Holdings Limited as the lender (the "Lender"), the Chargors granted to the Lender a charge (the "Charge") over 110,000,000 shares of HK\$0.10 each in the capital of Star Telecom International Holding Limited.
Pursuant to an Option Agreement dated 19th December 1996 entered into between Mr Wong Kam Fu and Chu Wai Fun as the grantors (the "Grantors") and Grand Orient Limited as the grantee (the "Grantee") and in consideration of HK\$1.00 paid by the Grantee to the Grantors, the Grantors granted to the Grantee an option (the "Option"), to purchase up to 144,585,232 shares of HK\$0.10 each in the capital of Star Telecom International Holding Limited at a consideration of HK\$2.00 per Option Share in respect of which the Option is exercised which may be exercised once only by the Grantee at any time and from time to time during the period from and excluding 19th December to and including the earlier of (a) 7th July 1997; (b) the date which is two months after the Grantee receives conformation from the Securities and Futures Commission that neither the Grantors nor the Grantee or any parties acting in concert with any of them will incur any bid obligation under rule 26 of the Hong Kong Code on Takeovers and Mergers as a result of any exercise of the Option; and (c) the Grantee notifying the Grantors that it waives the requirement referred to in (a).
Grand Orient Limited is a wholly owned subsidiary of China Telecom Limited which in turn is a wholly owned subsidiary of China Strategic Holdings Limited.
