- N1 237,131,271 shares are share interests in a unit trust and a discretionary trust.
- N2 The increased interest under this disclosure is from the sale of a put option with strike price of HKD5.20 and mature date on 22 January 1998. Guangdong Capital Holdings Ltd ("GCH") entered into a share custody agreement with B.T.(France) S.A. ("BT") on 21 October 1993 ("the Agreement") whereby GCH has disposed of a total of 42,000,000 shares in Guangdong Investment Ltd ("the Shares") to BT. BT has then granted to GCH an option to call for the delivery of the Shares under certain conditions in accordance with the Agreement.
- N3 After the acquisition of 25,968,000 shares in Winsor Industrial Corp Ltd by Farnham Group Ltd, Mr Chow Chung Kai and Chou Wen Hsien are now deemed to be interested in these shares. (These shares were previously held by Ocean Land Dev Ltd).
