- N1 Chan ChiChung Ronnie is deemed to be interested in certain shares of each of Hang Lung Development Co Ltd, Amoy Properties Ltd and Grand Hotel Holdings Ltd by virtue of his minor children's interest as beneficiaries of a discretionary trust (the "Trust"). Before December 15, 1997, the Trust held 476,034,580 shares of Hang Lung (equivalent to approximately 35.6% of the issued share capital of Hang Lung). On December 15, 1997, certain transfers have been made so that the Trust now only holds 383,034,580 shares of Hang Lung (equivalent to approximately 28.7% of the issued share capital of Hang Lung).
