- N1 By a sale and purchase agreement dated 21 January 1998, an indirect wholly-owned subsidiary of Chinese Estates Holdings Ltd has agreed to conditionally purchase from Double Entry Securities Ltd up to 433,217,742 shares in The Kwong Sang Hong Int'l Ltd, the holding company of Goldworld Int'l Ltd (holding 69,882,620 shares in Evergo China Holdings Ltd), at a price of HK\$1.70 per share.
