- N1 The Conditional Agreement for the Sale & Purchase of shares in Burwill Holdings Ltd dated 15/12/97 lapsed on 27/01/98.
- N2 Pursuant to the conditional Sale and Purchase Agreement entered into between Track Record Ltd, Bright Mark Investments Ltd and Mr Wong Ching Ping Alex as Vendors and Goldstream Group Ltd, an indirect subsidiary of Emperor Int'l Holdings Ltd as Purchaser, the Vendors will sell and the Purchaser will purchase all the shares beneficially owned by the Vendors, being not less than 327,000,000 shares and not more than 328,000,000 shares in Capital Asia Ltd.
- N3 On 29 December 1997, Century City Holdings Ltd ("CCH"), a company controlled by the Century City Int'l Holdings Ltd (of which the Company is a wholly-owned subsidiary), entered into an agreement for the sale of 57,000,000 shares in Paliburg Holdings Ltd ("PHL") at the consideration of HK\$6.50 per share (the "Sale of Shares"). The Sale of Shares was to be completed on or before 31 January 1998.
