**Tianjin Bohai Chemical Industry (Group) Company Limited (Stock Code: 1065)**

The Exchange has received a notification from Tianjin Bohai Chemical Industry (Group) Company Limited ("Tianjin Bohai") pursuant to section 20 of the Securities (Disclosure of Interests) Ordinance ("SDIO") reporting the findings of an investigation conducted by Tianjin Bohai pursuant to section 18 of the SDIO. As stated in the letter of 16 February 1998 from Tianjin Bohai, The Hongkong and Shanghai Banking Corporation Limited held 38,103,000 H shares in Tianjin Bohai as at 28 January 1998. The shareholdings represent approximately 11.21% of total number of Tianjin Bohai 340,000,000 H shares in issue and 2.86% of total number of Tianjin Bohai 990,000,000 A shares and 340,000,000 H shares in issue.
