- N1 In accordance with the conditional Sale and Purchase Agreement ("Agreement") entered into between Track Record Limited, Bright Mark Investments Limited and Mr. Wong Ching Ping, Alex as vendors and Goldstream Group Limited as Purchaser, the Vendors will sell and the Purchaser will purchase all the shares beneficially owned by the Vendors ("Sale Shares"), being not less than 327,000,000 shares and not more than 328,000,000 shares in Capital Asia Limited. The number of Sale Shares have been ascertained to be 327,329,102 shares. The number of Sale Shares was reduced to 248,320,102 shares following completion of the placing of 79,000,000 shares by Track Record Limited, one of the Vendors to independent investors on 3 March 1998. Subject to the subscription of 105,726,626 shares by Track Record Limited becomes unconditional before the completion of the Agreement, the Vendors shall sell 354,055,728 shares to the Purchaser.
