H1 . Amendment

N2 An agreement dated 27 January 1998 (as supplemented by two supplemental agreements dated 13 March 1998 and 3 April 1998 respectively) ("Toll Road Agreement") was entered into between a wholly-owned subsidiary of CCIHL and The New China Hong Kong Group Limited ("NCHK"), under which Toll Road Agreement approximately 106.46 million shares of Paliburg Holdings Ltd ("PHL") (the "Consider Shares") were agreed to be transferred to NCHK at a price of HK\$6.50 per share as consideration for the acquisition from NCHK of certain interest in a toll road in Sichuan, The People's Republic of China. Completion of the transaction is expected to be around early April 1998.

N3 Acquisitions were made from 02/04/98 to 09/04/98 at prices ranging from \$0.12 to \$0.126 per share.

N4 Bonus Issue

N5 Disposals were made from 01/04/98 to 02/04/98 at prices ranging from \$5.25 to \$5.45 per share.
