N1 Top System Investment Limited, a wholly-owned subsidiary of the Company, has entered into an agreement on 6 February 1998 with Monoland Assets Limited, a wholly-owned subsidiary of COSCO International Holdings Limited ("CIHL") for the sale and purchase of all the issued share capital and shareholders' loan in Modern Capital Investment Limited for the total consideration of HK\$1,658.7 million satisfied by the issue and allotment of 145,765,983 shares of HK\$0.10 each in the capital of CIHL to COSCO Investments Limited, which completion took place on 17 April 1998.

N2 Bonus Issue
