N2 Pelota Worldwide Ltd (Pelota") now has beneficial interest in an aggregate of 278,459,760 shares in the relevant share capital of the Company. Mr. So Sik a director of the Company and interested in that 278,459,760 shares of the Company beneficially owned by Pelota by virtue of his direct/indirect interest in Pelota. A share acquisition agreement (the "Agreement") relating to Pelota was entered into on 3 July 1998 between Touche Amora Ltd ("Touche Amora") as the seller and So Sik as the purchaser, pursuant to which Touche Amora agreed to sell and Mr. So Sik agreed to purchase 51% interest in the issued share capital of Pelota held by Touche Amora. After the completion of the Agreement, his direct/indirect interests in Pelota are as follows:-  
(i) Directly interested in 51% (previously nil) of the issued share capital of Pelota; and  
(ii) Mr. So Sik has been and still directly interested in 100% of the issued share capital of Yeoman International Ltd which holds 49% of the issued share capital of Pelota.
