- N2** 22,222,222 shares in Paliburg Holdings Limited were agreed to be sold at a total consideration of HK\$100,000,000 (i.e. HK\$4.50 per share) as consideration shares (the "Consideration Shares") for the acquisition of the remaining 51% shareholding interest in The New China Hong Kong Financial Services Limited by a wholly-owned subsidiary of Century City International Holdings Limited ("CCIH"), of which the Company is also a wholly-owned subsidiary, from a wholly-owned subsidiary of The New China Hong Kong Group Limited ("NCHK Company") ("51% Acquisition"), pursuant to a conditional agreement dated 7th September 1998 relating to the 51% Acquisition.
- N3** On 17th September 1998 (the "Completion Date"), part of the Consideration Shares, i.e. 15,777,778 shares, were sold at a total consideration of HK\$71,000,002 (i.e. HK\$4.50 per share) in connection with the completion of the 51% Acquisition.
