- N1** On 4 November 1998, Universal Appliances Limited and Super China Development Limited, a wholly-owned subsidiary of Universal Appliances Limited, entered into a conditional sale and purchase agreement for the acquisition of, among other things, 145,289,300 ordinary shares, representing approximately 63.2% of the entire issued ordinary shares in the capital of Cybersonic Technology Limited by Super China Development Limited from Johnson Ko, Kwan Wing Holdings Limited and Kwan Wing Development Limited for a consideration calculated at HK\$0.2622 per ordinary share.
- N2** Join Truth Limited is interested in 430,124,400 shares in the listed company. The entire issued share capital of Join Truth Limited is, in turn, owned by Silver Grant International Holdings Limited, China Nonferrous Metals Group (Hong Kong) Limited, Oriental Pearl Holdings Limited and Asia Like Securities Holdings Limited as to 41.84%, 25.10%, 8.37% and 24.69% respectively. On 3 November 1998, Join Truth Limited implemented a capital distribution and the 430,124,400 shares in the listed company, representing Join Truth Limited's 48.2% interest in the listed company were distributed to its shareholders in proportion to their respective shareholdings in Join Truth Limited as mentioned in the above. As a result, Join Truth Limited ceased to be interested in any shares of the listed company.
- N3** Silver Grant International Holdings Limited holds 41.84% interest in Join Truth Limited and accordingly has corporate interest in respect of 430,124,400 shares in the listed company in which Join Truth Limited was interested. On 3 November 1998, Join Truth Limited implemented a capital distribution and the 430,124,400 shares in the listed company, representing Join Truth Limited's 48.2% interest in the listed company were distributed to its shareholders in proportion to their respective shareholdings in Join Truth Limited. As a result, the Company received a distribution of 179,966,400 shares in the listed company representing 20.17% of the issued share capital of the listed company.
