Pearl holds a total of 232,200,000 Shares as trustee for the HCF Trust. 9,999 units in the HCF Trust are held by HSBC International Trustee Limited as trustee for the Ho Wai Leung Memorial Trust ("HWL Trust") which is a discretionary trust. Mr. Ho is deemed to be interested in these shares by virtue of the fact that he is one of the beneficiaries of the HWL Trust.
